Guest Policies

- Any Member in good standing may bring a guest at his or her own expense to use the Club's facilities and play golf on the Club's courses, except during leagues or during special events for which guests may not be eligible.
- A Member is allowed to bring a maximum of three guests per tee time.
- No Member may extend privileges to a guest which differ from those he or she is entitled.
- A Member must accompany his or her guest and is responsible to ensure that the guest's green fees are paid.

Members are responsible for the dress and behaviour of their guests.

- A Member bringing a guest to use the Club facilities is liable for any debt that such guest may incur in the Club and for any damage done by such guest to Club property
- Members may not bring a non-playing guest to use the driving range or the Club's practice facilities unless approved by a Club Professional who will have the sole discretion to approve or disapprove a request that a non-playing guest use the driving range or Club's practice facilities.
